HB 2509: Arizona's Homemade Food Law

Bill Facts & Personal Stories from Producers

As Arizonans recover from the pandemic and policymakers look to rebuild the economy, home-based food businesses can create jobs and expand access to local food, especially in rural and minority communities. These small food businesses have low startup costs and provide budding entrepreneurs—like farmers, single parents, and immigrants—with the flexibility and capital they need to support their families and their dreams. But, current policy restricts homemade food producers from selling the food of their choice.

Although Arizona allows people to sell a limited variety of homemade foods, current law prohibits the sale of perishable food, including any baked goods or treats requiring refrigeration, and many well-loved cultural dishes like elotes, tacos, and tamales. Without sensible legislative reform, vendors' only option is to operate in the shadows, lacking the protections they need to earn an honest living.

Increasing the accessibility and flexibility of selling cottage foods is especially important to our rural, female, disabled, and Latino populations—whether to earn supplemental income, continue important cultural traditions, or start businesses to support their families. According to research, 83% of cottage food producers are women.

HB 2509 expands the varieties of foods that home-based food producers may sell and makes it easier for Arizonans to buy, sell, and consume the foods of their choice.

Please support HB 2509, which will:

- Expand a safe, successful program that has been on the books for over a decade.
- Allow homemade food to be sold allowing producers from all walks of life to pursue their dreams as they see fit.
- Guarantee that home-based foods are protected at the state level, while arming consumers with the knowledge they need to buy delicious, home-cooked meals.
- Bring Arizona's laws up to speed with neighboring states like Utah and California, which both allow the sale of prepared foods and meals with great success.




Chel Lewis, Surprise, AZ
