#### **Narrative**

On October 3rd 2022 I, Officer Wright was patrolling inside the jurisdictional limits of the Spartanburg County Sheriff's Office on Interstate 85 North Bound near the 62 mile marker. Officer Wright observed a burgundy dodge charger traveling at a high rate of speed. Officer Wright also observed the vehicle following dangerously close to another vehicle. Officer Wright measured the vehicle's speed at 74 miles per hour in a well posted 60 mile per hour speed zone. Officer Wright conducted a traffic stop involving the vehicle near the 63 mile marker northbound. Officer Wright exited his marked patrol vehicle and approached the passenger side of the vehicle. Officer Wright smelled the odor of marijuana. Officer Wright spoke with the driver (identified as Ervan Jeanpierre) and asked for his driver's license. Mr. Jeanpierre advised Officer Wright that he did not have a driver's license with him, but he knew his information. Officer Wright asked Mr. Jeanpierre to step out of the vehicle and sit in the front seat of his patrol vehicle. Mr. Jeanpierre did so with out hesitation.

After Mr. Jeanpierre was sitting in the front seat of his patrol vehicle, Officer Wright smelled a strong odor of marijuana inside his patrol vehicle. Officer Wright asked Mr. Jeanpierre where he was going and where he was coming from. Mr. Jeanpierre advised Officer Wright that he was coming from Atlanta and going back to Charlotte. Mr. Jeanpierre advised Officer Wright that he went to Atlanta for his brother's birthday party and was hanging out with his friends and they stayed in an ARB&B. Officer Wright advised Mr. Jeanpierre that he smelled the odor of marijuana. Mr. Jeanpierre stated that there was about 2 grams of marijuana inside the vehicle. Officer Wright read Mr. Jeanpierre his miranda warnings. Mr. Jeanpierre stated that there was a firearm inside the glove box. Officer Wright called for another unit to back him up. When Officer Crow arrived on scene, Officer Wright asked the other two passengers to exit the vehicle. Officer Wright received consent from both passengers to search their person. Officer Wright read both passengers their miranda warnings. Officer Wright searched the vehicle. Officer Wright located a Glock handgun inside the dash of the vehicle and a clear and blue bag with a large amount of U.S. Currency. Officer Wright called for HSI to meet. During the search of the vehicle, Officer Wright located a bag in the driver side with a green leafy substances inside. Officer Wright located a black backpack in the truck of the vehicle (Mr. Jeanpierre identified the bag as his) with a clear/white bag and mushrooms inside. Mr. Jeanpierre stated that he bought the mushrooms for a party that was coming up and that they were his. Mr. Jeanpierre was arrested and transported to the Spartanburg County Sheriff's Officer for Processing with out incident. Mr. Jeanpierre was transferred to the Spartanburg County Detention staff at the Sheriff's Office. All evidence was turned over to the evidence technicians at the Spartanburg County Sheriff's Office.

#### **Narrative**

ON 10/4/2022 I SGT. JAMIE RENFROE, A FLORENCE COUNTY DEPUTY WAS PATROLLING INTERSTATE 85 IN SPARTANBURG COUNTY DURING OPERATION ROLLING THUNDER AND MADE CONTACT WITH A WHITE IN COLOR PASSENGER BUS THAT WAS FOLLOWING A SEMI TRUCK AT ONE BUS LENGHT, WHICH IS NOT SAFE AND PRUDENT. RENFROE CONDUCTED A TRAFFIC STOP NEAR THE 75 MILE MARKER SOUTH BOUND FOR FOLLOWING TO CLOSE, THE BUS PULLED TO THE OUTSIDE SHOULDER. THE PASSENGER BUS WAS A PANDA BUS BEARING A MA PLATE OF

RENFROE MADE CONTACT WITH THE DRIVER AND REQUESTED HIS LICENSE AND REGISTRATION, HE COMPLIED. THE DRIVER WAS IDENTIFIED AS DAO YANG DOB WHILE TALKING WITH THE DRIVER AT THE BUS DOOR, THERE WAS A VERY STRONG ODOR OF RAW MARIJUANA PRESENT. I ASKED THE DRIVER TO MY PATROL VEHICLE FOR ENFORCEMENT ACTION. CPL. BRANDON BRAXTON ARRIVED WITH A DRUG DETECTION K9 AND BRAXON CONDUCTED A FREE AIR SNIFF AT THE LUGGAGE COMPARTMENT THAT THE DRIVER OPENED. DURING MY ENFORCEMENT ACTION BRAXTON STATED THE K9 DID SHOW A POSITIVE ALERT TO THE BUS.

CPL. TOMMY RAUCH AND CPL. TYLER NICHOLSON ARRIVED AND A PROBABLE CAUSE SEARCH WAS CONDUCTED. DURING THE COURSE OF THE SEARCH BRAXTON LOCATED A SUITCASE CONTAINING SEVERAL VACUUMED SEALED BAG OF A GREEN LEAFY SUBSTANCE CONSISTENT WITH MARIJUANA PER MY TRAINING AND EXPERIENCE, PACKAGING FOR RESALE AND 9 PSILOCYBIN MUSHROOM CANDY BARS. A BLACK SUITCASE WAS ALSO LOCATED THAT CONTAINED A BLACK BAG OF MARIJUANA AND A ZIPLOC BAG OF GREEN IN COLOR BAR TYPE PILLS.

UNITS MADE CONTACT WITH THE BUS OCCUPANTS AND CHECKED BAGS ABOARD THE BUS. SEVERAL BAGS CONTAING MARIJUANA WAS LOCATED THROUGHOUT THE BUS THAT WENT UNCLAIMED. A MALE SUBJECT WAS FOUND TO BE IN POSSESSION WITH A LARGE SUM OF U.S. CURRENCY ON HIS PERSON AND A SMALL BLACK BAG ALSO CONTAINING CURRENCY. THE SUBJECT IS INDENTIFIED AS TORREY STEVENSON DOB DURING THE SEARCH OF THE SEAT THAT STEVENSON WAS SITTING, UNITS LOCATED A COAT AND NICHOLSON LOCATED A SMALL BAGGIE OF A POWDER SUBSTANCE THAT WAS TESTED TO BE METH. STEVENSON WAS ARRESTED. UNITS REMOVED THE CURRENCY FROM STEVENSON'S PERSON AND BLACK BAG. THE CURRENCY WAS WRAPPED WITH RUBBER BANDS, CONSISTENT WITH ILLEGAL PROCEEDS THROUGH MY TRAINING AND EXPERIENCE. STEVENSON STATED TO THIS UNIT THAT THE CURRENCY WAS \$15,000.00 AND THEN TOLD HOMELAND SECURITY AGENT THAT WAS ONSENE THAT IT WAS \$17,000.00.

THE SUITCASES LOCATED UNDER THE BUS THAT CONTAINED CONTRABAND WENT UNCLAIMED. THE BUS DRIVER WAS RELEASED WITH A WARNING TICKET FOR FOLLOWING TO CLOSE (210041552675221004125000). STEVENSON WAS ARRESTED FOR POSSESSION OF METH AND TRANSPORTED TO THE COMMAND POST. THERE PER HSI AND SPARTANBURG NARCOTICS, STEVENSON SIGNED OVER THE CURRENCY THAT PER HSI HAS A TOTAL OF \$20,373.00. THE TOTAL CONTRABAND WAS 2931 GRAMS OF MARIJUANA, .08 GRAMS OF METH, 64 GRAMS OF PILLS, AND 9 PSILOCYBIN MUSHROOM CANDY BARS. ALL CONTRAND WAS TURNED OVER TO SPARTANBURG COUNTY SHERIFF'S OFFICE. NO OTHER INFORMATION BY SGT. JAMIE RENFROE AT THIS TIME.

#### **Supplement Pennington L**

On October 4th of 2022, Inv. Vassar and I (Inv. Pennington) responded to the 7600 I-85 SB located in Spartanburg County, in reference to illegal narcotics being located from a traffic stop conducted by Florence County Sheriff's Office. Florence County Deputy K9 Ruins was deployed on this traffic stop resulting in a positive indication for possible illegal narcotics. A black bookbag, a large multi-colored rolling suitcase, a small black rolling suitcase, and two black handbags were unaccounted for that contained GPM.

A B/M identified as Torrey Stevenson was located on the bus and inside Torrey's red and black jacket was an opened bag containing misc. pills and crystal rock like substances. Florence County Deputy B. Braxton stated a portion of the substance located inside the plastic bag was field tested and returned positive for amphetamines. The bag was weighed using an uncertified scale returning to approximately .8 grams. This bag contained misc. items. including two circular pink pills imprinted "K 56." According to "Drugs.com" the pills returned to Oxycodone Hydrochloride Sch. II. Torrey was located with \$20,373.00 in U.S currency. Torrey signed over this money to the SCSO. Seizure paperwork was signed by Torrey. See Inv. Vassar supplement for further.

Torrey was placed under arrest for possession of Sch. II narcotics. Florence County will be seeking warrant.

Narcotics collected from Torrey was placed into BB#S33691 and turned into Evidence for further analysis.

ON 10-04-2022 I CPL BRAXTON WAS ASKED TO CONDUCT A FREE AIR SNIFF OF A COMERCIAL BUS THAT WAS STOPPED BY SGT RENFROE AT THE 75 MILE MARKER SOUTH BOUND ON INTERSTATE 85 LOCATED IN SPARTANBURG COUNTY SOUTH CAROLINA. I CPL BRAXTON ARRIVED ON SCENE AND REMOVED K-9 RUIN FROM MY PATROL VEHICLE THAT IS NATIONALLY CERTIFIED BY APCA (AMERICAN POLICE CANINE ASSOCIATION) TO ALERT TO HE ODORS OF MARIJUANA, COCAINE, HEROIN AND METH. BEFORE I DEPLOYED K-9 RUIN I WAS ADVISED BY SGT RENFROE THAT HE COULD SMELL THE ODOR OF MARIJUANA COMING FROM THE BUS WHILE TALKING WITH THE DRIVER, I CPL BRAXTON OBSERVED THE DRIVER TO OPEN THE LUGGAGE COMPARTMENT DOORS AND WALK TO THE FRONT OF SGT RENFROES PATROL VEHICLE. I CPL BRAXTON DEPLOYED K-9 RUIN ON THE BUS AND NOTICED K-9 RUIN TO FOLLOW NARCOTIC ODOR INSIDE THE LUGGAGE AREA I CPL BRAXTON NOTICED K-9 RUIN TO GIVE A STRONG BREATHING CHANGE AND NOTICED K-9 RUIN TO BECOME VERY EXCITED AND NOTICED K-9 RUIN HAVING TROUBLE SOURCING THE ODOR. I CPL BRAXTON KNOW THROUGH MY TRAINING AND EXPIERNECE WITH K-9 RUIN THAT THIS IS AN INDICATION OF LARGE AMOUNTS OF NARCOITCS BEING PRESENT THIS MAKES SOURCING THE ODOR TIME CONSUMING FOR A K-9. K-9 RUIN SOURCED THE ODOR TO A MULTI COLOR BAG AND BECAME VERY EXCITED AND STARTED BITING AND SCRATCHING THE BAG IN ATTEMPT TO GET TO THE ODOR THAT WAS COMING FROM THE BAG. ON 10/04/2022 I, CPL. K.T. NICHOLSON, WAS ON PATROL ON INTERSTATE 85 AROUND THE 72 MILE MARKER SOUTHBOUND. WHICH IS LOCATED IN SPARTANBURG COUNTY. CPL. NICHOLSON OBSERVED A GREYHOUND BUS TRAVELING IN THE NUMBER 2 LANE OF A THREE LANE INTERSTATE. THIS BUS FAILED TO MAINTAIN ITS LANE OF TRAVEL AND DRIFTED CROSSED INTO THE NUMBER ONE LANE. CPL. THE DRIVER THEN OPENED THE LUGGAGE COMPARTMENTS OF THE BUS. CPL BRAXTON THEN DEPLOYED HIS K9 RUIN FOR A FREE AIR SNIFF. CPL. BRAXTON ADVISED CPL. NICHOLSON THAT HIS K9 RUIN DID NOT ALERT TO THE LUGGAGE COMPARTMENT OF THE BUS. THE DRIVER OF THE BUS THEN STATED "ITS UP TOP" AND REQUESTED FOR LAW ENFORCEMENT TO CHECK THE PASSENGER COMPARTMENT OF THE BUS. SGT. RENFROE AND CPL. RAUCH MADE CONTACT WITH PASSENGERS ON THE BUS. WHILE CPL. NICHOLSON WAS WRITING A WARNING FOR THE STOP SGT. RENFROE ASKED FOR CPL. NICHOLSON'S ASSISTANCE ON THE BUS. CPL. NICHOLSON ASSISTED WITH A SUBJECT THAT WAS DETAINED BY CPL. RAUCH. CPL. NICHOLSON IDENTIFIED THIS SUBJECT BY HIS NORTH CAROLINA DRIVER'S LICENSE NUMBER AS MR. TEVARIS DEONDRE BOYD. MR. BOYD STATED THAT HE HAD A BAG OF MONEY. NICHOLSON ISSUED A WARNING TO THE DRIVER OF THE BUS AND ADVISED HER SHE WAS FREE TO LEAVE. CPL. NICHOLSON ARRESTED MR. BOYD FOR THE CHARGE OF SIMPLE POSS. OF MARIJUANA. CPL. NICHOLSON THEN TRANSPORTED THE EVIDENCE AND MR. BOYD FROM THE SCENE TO THE SPARTANBURG COUNTY SHERIFF'S OFFICE. MR. BOYD WAS BOOKED AND THE EVIDENCE WAS LOGGED IN.

#### **Supplement KYLE K**

SUPPLEMENTAL REPORT:

On October 5, 2022 Investigator K. Kyle received a request to assist with this investigation of a traffic stop of a Greyhound bus.. Inv. Kyle responded to the scene of the traffic stop. Inv. Kyle was advised that a large quantity of U.S. Currency had been located in a bag found at the feet of Michael BROADNAX. Inv. Kyle was also advised that officers located a black luggage bag in the passenger compartment underneath the bus that contained three vacuum-sealed plastic bags containing a white powdery substance. Officers suspected that BROADNAX was the owner of both bags but BROADNAX claimed not to be associated with either bag. Inv. Kyle searched the luggage bag and found a key chain which had a BMW key fob, one blue and white toothbrush in a plastic bag, and one pair of red and black Guess slides amongst other miscellaneous clothing and toiletry items. Inv. Kyle was advised that BROADNAX spoke with Homeland Security Investigation (HSI) Investigators about the U.S. Currency and signed a form relinquishing any ownership of the U.S. Currency. BROADNAX and the Greyhound bus were released from the scene before Inv. Kyle was able to speak with BROADNAX about the suspected drugs found under the bus.

Inv. Kyle returned to the Rolling Thunder command post, 8045 Howard St, Spartanburg, SC 29303 where he took custody of all the evidence and turned it in to the Evidence department.

Inv. Kyle requested that the plastic bags that the white powdery substance were found in be fingerprinted.

On October 6, 2022 Inv. Kyle contacted the Greenville DNA Lab to confirm whether the toothbrush and Guess slides were eligible to be entered into CODIS. The lab confirmed that the items would be eligible for entry.

On October 10, 2022 Inv. Kyle went to the Evidence department. Inv. Kyle removed the Guess slides and toothbrush from the black luggage bag, listed as Item 1. Inv. Kyle then packaged the Guess slides as Item 10 and the toothbrush as Item 11.

Investigators received the report form the Forensic Analysis Lab which showed the the white powder substance to be cocaine with a total weight of 2,402.4 grams.

On October 11, 2022 Inv. Kyle checked Items 10 and 11 out from Evidence and transported them to the Greenville Law Enforcement Center, 4 McGee St, Greenville, SC 29601. Inv. Kyle turned the items into Property and Evidence for DNA testing.

On October 17, 2022 Investigators contacted Eden Police Department in Eden, NC. Eden PD investigators were familiar with Michael BROADNAX. During previous investigations they have received information that BROADNAX lives in the same apartment complex as his father. Eden PD officers have also stopped Michael BROADNAX in a vehicle belonging to his father that was registered to Charles BROADNAX.

Investigators have checked BROADNAX's NCIC Criminal History records and found him to have arrests for including but not limited to Felony Possession of Cocaine, Possession Methamphetamine, Possession Drug Paraphernalia, Trafficking in Methamphetamine, Trafficking in Cocaine, and PWISD Marijuana.

Inv. Kyle presented the facts of this case to Spartanburg County Magistrate Judge Q. Wood. Judge Wood issued warrant # 2022A4210102096, Trafficking in cocaine 400 grams or more, for the arrest of Michael BROADNAX.

The warrant information was placed into NCIC as a wanted record for BROADNAX to include extradition in surrounding states. Investigators contacted Eden PD Investigator R. Hash and provided the warrant and NCIC record information.

On October 24, 2022 Investigators were contacted by Eden PD Investigator R. Hash who advised that BROADNAX had been located and arrested at the Rockingham County Courthouse, 170 NC Hwy 65, Reidsville, NC 27320, for the outstanding arrest warrant. Inv. Hash advised that BROADNAX was currently being held at the Rockinhgam County Jail, 130 Justice Center Dr, Reidsville, NC 27320.

Inv. Kyle, Sergeant J. Ruane, and Homeland Security Investigations (HSI) Special Agent J. Bardole drove to the Rockingham County Jail and met Inv. Hash. Inv. Hash signed a DNA search warrant based upon information from this investigation with Inv. Kyle present to swear in front of the Rockingham County Judge.

Investigators then conducted a recorded interview with BROADNAX in a Rockingham County Sheriff's Office (RCSO) interview room. During the interview Inv. Kyle executed the search warrant and obtained two buccal swabs from BROADNAX. The buccal swabs were secured in a Buccal Swab Collection kit and kept by Inv. Kyle. RCSO Investigator R. Burns provided an electronic file copy of the recorded interview to Inv. Kyle. BROADNAX was provided a copy of the search warrant. Inv. Hash signed the return for the search warrant in front of the issuing judge and provided a copy to Inv. Kyle.

On October 25, 2022 the buccal swabs were designated Item 12 and placed into Evidence at the Spartanburg County Sheriff's Office, 8045 Howard St, Spartanburg, SC 29303.

On October 26, 2022 Inv. Kyle received a copy of the Greyhound bus passenger manifest for bus 86966 on October 5, 2022. The bus traveled from Raleigh, NC to Atlanta, GA. The records were originally subpoenaed by HSI Criminal Analyst B. Lowe as part of the investigation for this case. Inv. Kyle reviewed the passenger manifest and found no record of Michael BROADNAX as a listed passenger. Investigators understand that BROADNAX appeared to be traveling as a passenger under a false name which investigators know to be a common method for those involved in the trafficking of illegal drugs.

On November 3, 2022 Investigator J. Gilstrap checked Item 12 out from Evidence and transported it to the Greenville Law Enforcement Center, 4 McGee St, Greenville, SC 29601. Inv. Gilstrap turned the item into Property and Evidence for DNA testing.

On March 13, 2023 Inv. Kyle received the DNA lab reports from the Greenville County Forensic DNA Laboratory. The report details that the DNA sample from BROADNAX matches DNA found on the toothbrush and two shoes. It should be noted that the toothbrush only matched the DNA from BROADNAX and is approximately 238 octillion times more likely than a coincidental match to a random unrelated individual.

On October 5, 2022 Sgt. Ruane assisted with a traffic stop of a Greyhound bus. Sgt. Ruane responded to the scene of the traffic stop. Inv. Kyle advised Sgt. Ruane that a large quantity of U.S. Currency had been located in a bag found at the feet of Michael BROADNAX, and that officers located a black luggage bag in the passenger compartment underneath the bus that contained three vacuum-sealed plastic bags containing a white powdery substance. Officers suspected that BROADNAX was the owner of both bags, but BROADNAX claimed not to be associated with either bag. Inv. Kyle searched the luggage bag and found a key chain which had a BMW key fob, one blue and white toothbrush in a plastic bag, and one pair of red and black Guess slides amongst other miscellaneous clothing and toiletry items. Sgt. Ruane was advised that BROADNAX spoke with Homeland Security Investigation (HSI) Investigators about the U.S. Currency, and signed a form relinquishing any ownership of the U.S. Currency. BROADNAX and the Greyhound bus were released from the scene before Investigators were able to speak with BROADNAX about the suspected drugs found under the bus.

Sgt. Ruane then contacted Nationwide to attempt to determine ownership of the vehicle to the BMW fob. Sgt. Ruane provided the VIN to Nationwide, and Nationwide stated that the BMW with same VIN is currently insured by them. Nationwide provided the policy names Cynthia Broadnax (DOB provided), married, spouse, driver, and Charles Broadnax (DOB provided), male married primary named insured, driver. The address provided is 631 Fagg Dr, Apt 8A, Eden, NC 27288-5336. A copy of this information from Nationwide will be placed into this case file.

Sgt. Ruane then ran the VIN through NCIC out of NC. The VIN comes back to Cynthia Durham Broadnax, 631 Fagg Dr, Apt 8A, Eden NC, 27288-5336. The tag on the vehicle is NC

On October 13, 2022 Investigator Hash from Eden NC was able to locate the BMW at 631 Fagg Dr., Eden NC 27288. Inv. Hash sent Sgt. Ruane photographs of the BMW, and Sgt. Ruane placed them on a disc for this case file.

On October 20, 2022 Investigator Hash obtained a rent roll for the apartments. Charles Broadnax is showing renting Apt. 8A. Inv. Hash sent Sgt. Ruane a photograph of the information he received, and Sgt. Ruane placed them on a disc for this case file.

Upon speaking to Newton, we learned that they claimed to be moving to Atlanta, Georgia from Charlotte, NC to move to begin a new endeavor in the hair business. The occupants claimed that they were driving a rental vehicle to Atlanta to move a few items and then subsequently fly back to Charlotte to pick up Lightner's vehicle that had to have an oil change. While speaking to the occupants, we smelled the odor of what we know to be marijuana. We know this odor from our training and experience as law enforcement officers.

A probable cause search of the vehicle was conducted and we subsequently located a large amount of United States Currency. An investigator with the Homeland Security Investigations arrived on scene and began to speak to the occupants. The investigator ultimately seized the US Currency after interviewing the occupants. This ended our portion of this investigation and the currency investigation will be handled by Homeland Security. Our Body Worn Cameras and In Car Camera were activated during this incident. Nothing further at this time.

On Thursday, October 6, 2022, DL Gilbert and J. Bembenek (Greenville County Sheriff's Office) were patrolling Interstate 85 in Spartanburg County. While monitoring traffic at the 80 mile marker south, Gilbert noted a black Chevrolet Suburban following another vehicle too closely. Gilbert got the vehicle stopped at the 78 mile marker and found it to be driven by Jamaine Tyrone Lawrence (Georgia driver's license Dupon passenger side approach Gilbert was immediately overwhelmed with the odor of marijuana. The vehicle was occupied by five (5) individuals. A probable cause search of the vehicle was eventually conducted, which produced 953 grams of marijuana, and U.S. currency totaling \$35,029.

It should be noted Rhyan Michael Hammond-Greene is a wanted subject from New York.

A more detailed report will follow.

On Thursday, October 6, 2022, DL Gilbert and J. Bembenek (Greenville County Sheriff's Office) were patrolling Interstate 85 in Spartanburg County. While monitoring traffic at the 80 mile marker south, Gilbert noted a black Chevrolet Suburban, in lane number two, following another vehicle too closely. This is a violation of 56-5-1930, but is also a safety concern Gilbert had for the occupant of the Suburban and the surrounding traffic.

Gilbert caught up to the vehicle and positioned himself behind it, observing the vehicle license from Rhode Island, After signaling the driver to pull over with blue lights the vehicle did so at the 78 mile marker without incident.

Gilbert exited his unmarked patrol vehicle and conducted a passenger side approach on the Suburban. As Gilbert reached the passenger window, he was overwhelmed with the odor of marijuana emitting from the Suburban. Gilbert observed several occupants in the front and back seats, but was uncertain how many occupants there were at the time.

Gilbert explained the reason for the stop to the driver, who was identified by a Georgia driver's license as Jamaine Tyrone LAWRENCE. Gilbert asked LAWRENCE to exit the Suburban and step behind it. Gilbert noted LAWRENCE tried to exit the Suburban without putting it in park, and reminded him to do so. Gilbert directed LAWRENCE to sit in the passenger seat of the patrol vehicle. Once LAWRENCE was positioned in the passenger seat, Gilbert started the enforcement action. Gilbert asked LAWRENCE about the status of his license, and without making eye contact LAWRENCE advised they were clear. Gilbert noted LAWRENCE was busy texting on his phone. LAWRENCE advised he rented the vehicle.

LAWRENCE advised they were traveling to Georgia, and were traveling from New York. Gilbert asked LAWRENCE if they had thrown the "weed" out of the vehicle,

and LAWRENCE replied he didn't have any. Gilbert inquired to what the smell was, and LAWRENCE offered they had smoked some back in New York. Gilbert reassured him it was today they had smoked it. Gilbert asked if LAWRENCE was sure, and he replied, "I'm positive." All while not making eye contact with Gilbert. LAWRENCE seemed to be pre-occupied looking for the rental agreement on his phone.

LAWRENCE advised he was his own contractor. LAWRENCE wouldn't advise who was in the vehicle with him, replying "I don't know these dudes names, if they want to give you their names they give you their names." (It was obvious to Gilbert LAWRENCE was not going to offer any information about anyone inside the vehicle.) LAWRENCE tried to advise Gilbert there was nothing going on, and Gilbert advised LAWRENCE at that time, he could readily smell marijuana coming from the Suburban. LAWRENCE had advised he'd been arrested before, but there were no outstanding warrants for his arrest presently. LAWRENCE showed Gilbert rental paperwork on his phone. Gilbert confronted LAWRENCE on the fact that the paperwork showed the vehicle was due back at JFK Airport on October 4, 2022. LAWRENCE advised he extended the rental.

LAWRENCE asked why he was stopped, and Gilbert informed him for a second time. LAWRENCE was obviously in disagreement with Gilbert. Gilbert had previously called for any assistance in the area for back-up to conduct a detailed hand search of the vehicle.

LAWRENCE insisted there was no marijuana in the vehicle, and everyone had luggage in the vehicle.

Gilbert began to explain probable cause to LAWRENCE when he began changing the subject, stating he was just trying to make it home. Gilbert explained the smell of marijuana gave him probable cause to search the vehicle without LAWRENCE's consent. LAWRENCE Advised he wasn't giving Gilbert consent to search his vehicle, and Gilbert explained he didn't need his consent.

Gilbert then asked LAWRENCE To step out to the passenger side of the patrol vehicle. Gilbert then approached the passenger side of the Suburban and asked the front seat passenger to exit (Aaron), and conducted search of his person for weapons and contraband. Aaron advised they hadn't smoked any marijuana for a long time. Gilbert asked the back seat passenger to exit the vehicle and conducted a search of his person for weapons and contraband. That passenger had a significant amount of U.S. Currency in his pocket, and claimed he had no idea how much it was. He Eventually admitted it could be \$5,000. Gilbert then asked the last two passengers to exit the vehicle. The fourth passenger had U.S. Currency in his pocket as well. The fifth passenger admitted there was approximately \$8,000 to \$9,000 on his person. That passenger explained he smoked marijuana not long ago when they stopped. He also advised he didn't know if any more marijuana was in the vehicle.

Gilbert then conducted a detailed hand search of the vehicle. In the right front passenger floorboard was a small bag containing U.S. Currency. Gilbert could see "roaches" (smoked marijuana cigarettes that were not finished) in the middle console cup holder. This was obviously part of the smell coming from the vehicle.

Gilbert called the Florence County Sheriff's Office members by phone for back up help searching the vehicle. Gilbert found a small brown paper bag containing marijuana in the rear cargo area of the back seat.

Jamie Renfrow and another Deputy with the Florence County Sheriff's Office

arrived to assist with the search. Immediately Florence County found a large amount of marijuana in the rear cargo area of the Suburban.

There were fraudulent checks found inside the Suburban.

Photographs were taken roadside, and also at the Sheriff's Office and uploaded in the "files" section of this report.

The Suburban, occupants and traffic scene were eventually moved to the Spartanburg County Sheriff's Office. The Suburban and all the U.S. Currency in bags were kept on camera by Gilbert's patrol vehicle for the trip. The Suburban was driven by Deputy Bembenek. Upon arrival, the bags and U.S. Currency were assigned to each individual owner, and then handed over to the Spartanburg County Sheriff's Office Narcotics Investigators along with the marijuana for a final count, which will be detailed in a separate supplemental report.

On October 6, 2022 while working Operation Rolling Thunder, Inv. Gilbert conducted a traffic stop within Spartanburg County, SC. During the course of the stop, Inv. Gilbert located a quantity of marijuana and a quantity of US currency on each suspect. Five (5) people were placed under arrest on scene.

Inv. Gilbert turned over the marijuana and US currency to myself (Cpl. Vassar) and Inv. Pennington for processing and forfeiture. The following was seized as evidence:
