On 10-5-22 while on patrol I, PFC Swanger initiated a lawful traffic stop on interstate 85 Southbound exit 72 on a dark green in color Cadillac SUV in reference to the operator following too closely to other vehicles. Upon making contact with the operator of the vehicle Brady Pollock, I immediately observed the odor of Marijuana emitting from inside the vehicle. At this point I had Mr. Pollock step out of the vehicle to conduct a probable cause search of the vehicle.

Once Mr. Pollock was out of the vehicle a search was conducted inside of the vehicle. During the search of the vehicle a small amount of a green leafy plant like substance was found in the passenger side seat in a book bag. I also discover a loaded 9 mm Taurus handgun in the bottom of the bag. After a further search of the book bag a small baggy containing multiple multicolored pills were discovered in a small baggy. When asked about the pills Mr. Pollock stated that they were Ecstasy. I also discovered one small blue in color pill in the floor board that was ran through a pill database and came back as a Oxycodone.

Due to the fact that Mr. Pollock had the handgun in the bag and not in a glove box or storage compartment, he is being charged with unlawful carry of a weapon. Mr. Pollock is also being charged with Possession With Intent to Distribute Methamphetamine due to the weight of the Ecstasy pills being 4.2 grams and testing positive for Methamphetamine. He is also being charged with Simple Possession of Marijuana 5.1 grams and he is being charged with Possession of a Schedule II controlled substance.

Mr. Pollock was transported to the Spartanburg County Sheriff's Office where he was booked in for the above stated charges. Mr. Pollock was issued a uniform traffic warning (008874-AT) for the traffic offense of following too closely. Mr. Pollock's 2015 Cadillac SUV was escorted to the Sheriff's Office where it was then towed by SAT Automotive to their lot.

ON 10-5-2022 CPL BRAXTON WAS ON PATROL ON INTERSTATE 85 AROUND THE 80 MILE MARKER IN THE SPARTANBURG AREA OF SPARTANBURG COUNTY. CPL BRAXTON OBSERVED A BLACK NISSAN PATHFINDER WITH NEW MEXICO TAGS FOLLWOING TO CLOSELY TO A TRACTOR TRAILER WHICH WAS LESS THAN A CAR LENGTH AWAY AT 70MPH WHICH IS A UNSAFE FOLLOWING DISTANCE. CPL BRAXTON CONDUCTED A LAWFUL TRAFFIC STOP JUST PAST THE 80 SOUTH BOUND MILE MARKER. CPL BRAXTON OBSERVED THE VEHICLE TO FAIL TO STOP FOR A SHORT DISTANCE BEFORE COMING TO A STOP ON THE RIGHT SIDE OF THE INTERSTATE.

CPL BRAXTON EXITED HIS PATROL VEHICLE AND MADE A PASSENGER SIDE APPROCH AND MADE CONTACT WITH 2 MALE SUBJECTS, CPL BRAXTON ASKED FOR THE DRIVERS LICENCE AND REGISTRATION. THE DRIVER PRODUCED A FAKE INTERNATIONAL DRIVERS LICENCE AND PASSPORT. CPL BRAXTON ADVISED THE PASSENGER AND DRIVER THAT THE DOCUMENTS WERE FAKE. THE PASSENGER STATED IT WAS NOT FAKE THAT IT WAS REAL, CPL BRAXTON KNOWS THROUGH HIS TRAINING AND EXPERIENCE THAT THE DOCUMENTS WERE IN FACT FAKE. CPL BRAXTON ASKED THE SUBJECTS WHERE THEY WERE COMING FROM? THE PASSENGER ASKED WHAT STATE WAS HE IN AND STARTED TO ACT LIKE HE DID NOT UNDERSTAND WHAT CPL BRAXTON WAS ASKING. THE PASSENGER WOULD ONLY SAY HE WAS HEADED TO DALLAS AND THAT HE WAS FOLLOWING HIS GPS.

CPL BRAXTON ASKED THE DRIVER TO EXIT THE VEHICLE AND WALK TO THE FRONT OF CPL BRAXTONS PATROL VEHICLE. CPL BRAXTON ASKED CPL RAUCH TO RESPOND AND CONDUCT A FREE AIR SNIFF WHILE CPL BRAXTON WAS CONDUCTING BUSSINESS DUE TO THE ACTIONS OF THE OCCUPANTS AND THE INSIDE OF THE VEHICLE THAT APPEARED TO BE LIVED IN THAT IS CONSISTENT WITH CRIMINAL ACTIVITY, THE INOCENT MOTORING PUBLIC KNOWS WHERE THEY ARE COMING FROM AND WHAT THEY WERE DOING IN THAT LOCATION. CPL BRAXTON FELT HE HAD RESONABLE SUSPICION TO BELIVE THAT THESE SUBJECTS WERE INVOLVED IN SOME SORT OF CRIMNAL ACTIVITY. CPL BRAXTON WAS ADVISED BY CPL RAUCH THAT HE OBTAINED A POSTIVE ALERT TO THE VEHICLE FOR NARCOITC ODOR.

CPL BRAXTON, CPL RAUCH AND SGT RENFROE REMOVED THE FRONT SEAT PASSENGER AFTER HE FAILED TO COMPLY WITH LAWFUL COMMANDS TO EXIT THE VEHICLE AND WAS DETAINED. CPL BRAXTON ALONG WITH SGT RENFROE CONDUCTED A PC SEARCH OF THE VEHICLE AND LOCATED A LARGE AMOUNT OF MONEY ORDERS, FAKE ID'S AND RECIPETS. CPL BRAXTON ALSO LOCATED MARIJUANA RESIDUE AND MARIJUANA GRINDERS INSIDE THE VEHICEL.

CPL BRAXTON CONTACTED HOMELAND SECURITY INVESTIGATIONS DUE TO THE LARGE AMOUNTS OF MONEY ORDERS AND FAKE ID'S CPL BRAXTON KNOWS THROUGH HIS TRAINING AND EXPERIENCE THAT THIS IS COMMONLY SEEN WITH INTERNATIONAL MONEY LAUNDERING GROUPS ALONG WITH FRAUD AND IDENTITY THEFT. HOMELAND SECURITY RESPONDED TO THE LOCATION AND SEIZED THE CURRENCY ESTIMATED TO BE AROUND 20,000. THE SUSPECTS WERE PLACED UNDER ARREST FOR FRAUD AND NO SC DL.

This is the supplement for SA Hudson:

On October 5, 2022, SS/A Edward Hudson responded to Interstate 85 South Bound near Exit 80 in Spartanburg, SC to assist Deputy Brandon Braxton of the Florence County Sheriff's Office, who had conducted a lawful traffic stop on a Black Nissan Pathfinder, bearing a New Mexico Upon arrival, Deputy Braxton had already removed the suspect, Daniel license plate STANCIU, from the vehicle and was conducting a lawful vehicle search. SA Meeks had arrived prior to my arrival and had provided STANCIU with Miranda Warning. During the search of the vehicle, an Illinois driver's license ( bearing STANCIU photograph, but the name of Jamel Achim was discovered. Along with the Illinois drivers' license was a Pennsylvania driver's license ( also bearing STANCIU photograph but in the name of Daniel Flores. SS/A McMahon contacted the Spartanburg County Communication Center (SCCC) in order to run both driver licenses. SCCC advised that both the Illinois and Pennsylvania driver licenses did not come back on file. A Homeland Security Investigations Intelligence Officer conducted a search on the names Daniel Flores and Jamel Achim and found both names appeared to be fraudulent in nature. At that time, STANCIU was advised he was under arrest for forgery and that further charges could follow upon additional follow up. Under excited utterance, STANCIU stated, "They are fake, I only use them for money transactions." Upon reviewing the items found during the vehicle search, it was discovered that the licenses had been used for gift cards, money transfers and obtaining bank cards. STANCIU was then placed into handcuffs and placed into S/A Meeks vehicle and transported to the Spartanburg County Sheriffs Office for processing. SS/A Hudson will be meeting with the Spartanburg County Magistrates Office to obtain a warrant for forgery zero-dollar amount for the Illinois driver's license and an additional warrant for forgery Zero Dollar amount for the Pennsylvania driver's license. Warrant numbers will be documented in supplemental report.

On 10/5/22 at 1512 hours, I responded to Deputy Dorsett, in reference to him being on a traffic stop and requesting a K9. Deputy Dorsett explained that he had reasonable suspicion to believe there could be illegal narcotics in the vehicle. Deputy Dorsett requested a free air sniff with a K9.

I deployed PSD Paco on a six foot leash attached to his flat collar. PSD Paco was placed in a sit at the front of the vehicle. I gave PSD Paco his narcotic detection command starting the sniff at the front passenger side head light, moving counter clockwise around the vehicle. PSD Paco jumped up at the open driver window, then continued down the vehicle towards the trunk. PSD Paco sniffed at the seam and head snapped back into it as he moved along it. PSD Paco displayed a breathing change and his tail started waging. I know these behaviors as PSD Paco being in target odor. PSD Paco came to his trained final response of a sit. PSD Paco was then secured in my vehicle. I spoke to the only occupant of the vehicle and he stated he smokes marijuana and knew the dog would alert. A quantity of marijuana was recovered from the vehicle.

BWC was activated. In-car video was active.

PSD Paco is currently certified as a Dual Purpose Team through the North American Police Work Dog Association.

On October 6th, 2022 I, Sgt. Allen (Cherokee County Sheriff's Office), was patrolling the area of I-85 Southbound around the 77 mile marker, Spartanburg, SC which is located in Spartanburg County and observed a gold in color passenger bus that was failing to maintain the lane that it was in. I initiated a lawful traffic stop on the passenger bus around the same location aforementioned. The bus was displaying Massachusetts tag number I made contact with the driver of the bus and identified him as Lawrence Frink, JR through his North Carolina state issued commercial drivers license. I advised Lawrence of my reasoning for the traffic stop. Lawrence advised me that he was used to this and that it's routine for him to get pulled over during his trips.

Lawrence advised me that there was 6 people on the bus and that they were traveling from New York to Atlanta, GA. Lawrence stated that he started his trip early this morning when he picked up his passengers. Lawrence also handed me over the trip log, registration, and insurance card for the bus. While standing at the front of the bus speaking with Lawrence, I could smell a strong odor of marijuana coming from inside of the bus. Lawrence asked me beforehand if I wanted him to open the luggage compartment beneath the bus and I told him that would be fine.

Trooper A. Blair with the South Carolina Highway Patrol came to the scene to assist me with a K-9 search. Trooper Blair advised me that his K-9 did not alert on anything underneath the bus.

Lt. B. Dorsett with the Cherokee County Sheriff's Office arrived on scene to also assist me with talking to the bus driver and everyone on the bus. A search of the bus was conducted due to the probable cause established with the odor of marijuana coming from inside of the bus. After searching a few book bags on the bus, a large quantity of a green leafy like substance (believed to be marijuana) was located. A clear baggie containing a green leafy like substance (believed to be marijuana) was also located inside of the luggage compartment beneath the bus inside of a suitcase.

Ronald Shorter, Mitchell Washington, and Deshawn Hilliard were the people questioned about the contents inside of the book bags and suitcase that they claimed as being theirs.

Ronald was found to be in possession of approximately 293.5 grams of what is believed to be marijuana inside of his book bag that he was carrying. Mitchell Washington claimed a bookbag and the suitcase that was located beneath the bus that contained approximately 215.5 grams of what is believed to be marijuana. Deshawn was the last suspect that was found to be in possession of a bookbag that contained 479.5 grams of what is believed to be marijuana. Ronald, Mitchell, and Deshawn were all placed under arrest and transported to the Spartanburg County Detention Center where they were booked in. Lt. Dorsett assisted in transporting Ronald and I transported the additional two suspects. All of the suspects will be charged with possession with the intent to distribute marijuana based on the evidence that was located.

On Thursday, October 6, 2022, DL Gilbert and J. Bembenek (Greenville County Sheriff's Office) were patrolling Interstate 85 in Spartanburg County. While monitoring traffic at the 80 mile marker south, Gilbert noted a black Chevrolet Suburban following another vehicle too closely. Gilbert got the vehicle stopped at the 78 mile marker and found it to be driven by Jamaine Tyrone Lawrence (Georgia driver's license Dupon passenger side approach Gilbert was immediately overwhelmed with the odor of marijuana. The vehicle was occupied by five (5) individuals. A probable cause search of the vehicle was eventually conducted, which produced 953 grams of marijuana, and U.S. currency totaling \$35,029.

It should be noted Rhyan Michael Hammond-Greene is a wanted subject from New York.

A more detailed report will follow.

On Thursday, October 6, 2022, DL Gilbert and J. Bembenek (Greenville County Sheriff's Office) were patrolling Interstate 85 in Spartanburg County. While monitoring traffic at the 80 mile marker south, Gilbert noted a black Chevrolet Suburban, in lane number two, following another vehicle too closely. This is a violation of 56-5-1930, but is also a safety concern Gilbert had for the occupant of the Suburban and the surrounding traffic.

Gilbert caught up to the vehicle and positioned himself behind it, observing the vehicle license from Rhode Island, After signaling the driver to pull over with blue lights the vehicle did so at the 78 mile marker without incident.

Gilbert exited his unmarked patrol vehicle and conducted a passenger side approach on the Suburban. As Gilbert reached the passenger window, he was overwhelmed with the odor of marijuana emitting from the Suburban. Gilbert observed several occupants in the front and back seats, but was uncertain how many occupants there were at the time.

Gilbert explained the reason for the stop to the driver, who was identified by a Georgia driver's license as Jamaine Tyrone LAWRENCE. Gilbert asked LAWRENCE to exit the Suburban and step behind it. Gilbert noted LAWRENCE tried to exit the Suburban without putting it in park, and reminded him to do so. Gilbert directed LAWRENCE to sit in the passenger seat of the patrol vehicle. Once LAWRENCE was positioned in the passenger seat, Gilbert started the enforcement action. Gilbert asked LAWRENCE about the status of his license, and without making eye contact LAWRENCE advised they were clear. Gilbert noted LAWRENCE was busy texting on his phone. LAWRENCE advised he rented the vehicle.

LAWRENCE advised they were traveling to Georgia, and were traveling from New York. Gilbert asked LAWRENCE if they had thrown the "weed" out of the vehicle,

and LAWRENCE replied he didn't have any. Gilbert inquired to what the smell was, and LAWRENCE offered they had smoked some back in New York. Gilbert reassured him it was today they had smoked it. Gilbert asked if LAWRENCE was sure, and he replied, "I'm positive." All while not making eye contact with Gilbert. LAWRENCE seemed to be pre-occupied looking for the rental agreement on his phone.

LAWRENCE advised he was his own contractor. LAWRENCE wouldn't advise who was in the vehicle with him, replying "I don't know these dudes names, if they want to give you their names they give you their names." (It was obvious to Gilbert LAWRENCE was not going to offer any information about anyone inside the vehicle.) LAWRENCE tried to advise Gilbert there was nothing going on, and Gilbert advised LAWRENCE at that time, he could readily smell marijuana coming from the Suburban. LAWRENCE had advised he'd been arrested before, but there were no outstanding warrants for his arrest presently. LAWRENCE showed Gilbert rental paperwork on his phone. Gilbert confronted LAWRENCE on the fact that the paperwork showed the vehicle was due back at JFK Airport on October 4, 2022. LAWRENCE advised he extended the rental.

LAWRENCE asked why he was stopped, and Gilbert informed him for a second time. LAWRENCE was obviously in disagreement with Gilbert. Gilbert had previously called for any assistance in the area for back-up to conduct a detailed hand search of the vehicle.

LAWRENCE insisted there was no marijuana in the vehicle, and everyone had luggage in the vehicle.

Gilbert began to explain probable cause to LAWRENCE when he began changing the subject, stating he was just trying to make it home. Gilbert explained the smell of marijuana gave him probable cause to search the vehicle without LAWRENCE's consent. LAWRENCE Advised he wasn't giving Gilbert consent to search his vehicle, and Gilbert explained he didn't need his consent.

Gilbert then asked LAWRENCE To step out to the passenger side of the patrol vehicle. Gilbert then approached the passenger side of the Suburban and asked the front seat passenger to exit (Aaron), and conducted search of his person for weapons and contraband. Aaron advised they hadn't smoked any marijuana for a long time. Gilbert asked the back seat passenger to exit the vehicle and conducted a search of his person for weapons and contraband. That passenger had a significant amount of U.S. Currency in his pocket, and claimed he had no idea how much it was. He Eventually admitted it could be \$5,000. Gilbert then asked the last two passengers to exit the vehicle. The fourth passenger had U.S. Currency in his pocket as well. The fifth passenger admitted there was approximately \$8,000 to \$9,000 on his person. That passenger explained he smoked marijuana not long ago when they stopped. He also advised he didn't know if any more marijuana was in the vehicle.

Gilbert then conducted a detailed hand search of the vehicle. In the right front passenger floorboard was a small bag containing U.S. Currency. Gilbert could see "roaches" (smoked marijuana cigarettes that were not finished) in the middle console cup holder. This was obviously part of the smell coming from the vehicle.

Gilbert called the Florence County Sheriff's Office members by phone for back up help searching the vehicle. Gilbert found a small brown paper bag containing marijuana in the rear cargo area of the back seat.

Jamie Renfrow and another Deputy with the Florence County Sheriff's Office

arrived to assist with the search. Immediately Florence County found a large amount of marijuana in the rear cargo area of the Suburban.

There were fraudulent checks found inside the Suburban.

Photographs were taken roadside, and also at the Sheriff's Office and uploaded in the "files" section of this report.

The Suburban, occupants and traffic scene were eventually moved to the Spartanburg County Sheriff's Office. The Suburban and all the U.S. Currency in bags were kept on camera by Gilbert's patrol vehicle for the trip. The Suburban was driven by Deputy Bembenek. Upon arrival, the bags and U.S. Currency were assigned to each individual owner, and then handed over to the Spartanburg County Sheriff's Office Narcotics Investigators along with the marijuana for a final count, which will be detailed in a separate supplemental report.

#### **Narrative**

On October 6th, 2022 I, Sgt. Allen, was patrolling the area of I-85 South Bound around the 78 mile marker, Spartanburg, SC which is located in Spartanburg County and observed a dark blue in color Greyhound bus bouncing from side to side within it's lane. Due to me being concerned about the safety of the driver and everyone on the bus, I initiated a traffic stop on the bus. I made contact with the driver of the bus and identified him as Solomon Ray through his Georgia state issued commercial drivers license and advised him of my reason for the traffic stop. Solomon advised me that there was 41 passengers on the bus and they were on the way to their next stop in Duncan, SC to pick up someone. Solomon stated that he started in New York and and they were on the way to Atlanta, GA.

I asked the driver of the bus for consent to search the luggage compartment beneath the bus and the driver gave consent. Trooper A. Blair with the South Carolina Highway Patrol arrived on scene to assist me with a K-9 search of the bus. The K-9 showed a positive alert on a few of the bags in the luggage compartment. A search was conducted of the bags and no illegal contraband was found.

Sgt. C. Painter (Cherokee County Sheriff's Office), Agent Christofedes (SLED), and myself all walked on the inside of the bus and conducted a search of the bags on the inside. While searching Casey Staples belongings, Casey advised us that he had a loaded firearm inside of his bookbag. Casey was escorted from the bus and placed into investigative detention.

A black in color Taurus G2 (serial number was located and we cleared it. A clear pipe (commonly associated with illegal narcotics) containing a white substance was located. A clear baggie containing a white powdery substance (believed to be methamphetamine, approximately 3 grams) was located on Casey's person. Once the bag of the powdery substance was field tested, it came back positive for methamphetamine. Casey was placed under arrest and transported to the Spartanburg County Detention Center where he was booked in. I will be speaking to a magistrate judge in reference to obtaining warrants on Casey for unlawful carrying of a weapon and for PWID methamphetamine due to the total approximate weight of it. Casey did not have a concealed weapons permit.

Solomon was issued warning number 200783-BC for improper lane use and released from the scene to continue on his route to Atlanta.
