On 10/4/2022 at approximately 1505 hours, I TFC. J. A. Norman was on patrol with in Spartanburg CO, SC. I observed a pickup truck turning from US221 onto I85 SB with a black male driver and a white male front passenger. I observed that both the driver and the [passenger did not have their seatbelts on. I conducted a traffic stop for the seatbelt violation. During the traffic stop investigation, it was determined that the front seat passenger, a white male was identified by a SC DL (SCDL# [REDACTED]) as Michael Christen Barnes (DOB: [REDACTED]). It was also determined that Mr. Barnes had a active warrant thru Spartanburg CO, SC. The warrant was confirmed, and Mr. Barnes was placed under arrest for the warrant. Narrative

On the incident date, Master Deputy Wasserman and Deputy Bembenek of the Greenville County Sheriff's Office were monitoring the flow of traffic near the 76 Mile Marker I-85 Northbound while participating in Operation Rolling Thunder in Spartanburg County, SC. At that time, deputies observed a yellow box truck following dangerously close to the vehicle that was in front of it. At that time, we conducted a traffic stop on the vehicle. After speaking with the occupants of the vehicle, deputies believed the occupants to be involved in criminal activity. Consent to search the vehicle was requested and granted. Upon searching the box truck, a large amount of counterfeit merchandise was located inside of the vehicle. At that time, the vehicle and the occupants were transported to the Spartanburg County Sheriff's Office. Upon searching the vehicle, we located a large amount of items that we were able to identify as counterfeit based on our training and experience as law enforcement officers.

At that time, we made contact with Homeland Security Investigators and informed them of our findings. After speaking to them, we made the determination to move the box truck to the Spartanburg County Sheriff's Office for a further and more detailed search. Officer Wright of the Duncan Police Department and Lt. McCoy of the Greenville County Sheriff's Office transported the two passengers of the box truck to the Spartanburg County Sheriff's Office. Once at the Spartanburg County Sheriff's Office, we began our search and located a large amount of counterfeit items ranging from hats, key chains, etc. The subjects then were interviewed by Homeland Security Investigators and were subsequently released from the Spartanburg County Sheriff's Office. All counterfeit items were subsequently seized and an inventory will be conducted and documented in a further supplemental. Our Body Worn Cameras and In Car Camera were activated during this incident.

Narrative

On 10/6/2022 at approximately 2025 hours, I, TFC. J. A. Norman, of the SC Highway Patrol, was on patrol with in Spartanburg CO, SC. I observed a dark colored Honda SUV struggle to maintain the lane of travel and was traveling well below the posted speed limit of 70 mph. At one time the vehicle was traveling 40mph within the 70 mph zone. I conducted a traffic stop for the lane violation and the low speed. I made contact with the driver and only occupant, a black male, introduced myself and explained the reason for the stop. I requested his driver's license, registration, and proof of insurance. The male provided a SC driver's license (SCDL# [REDACTED]) identifying him as Hunter, James Ebell III. Mr. Hunter had to be reminded that I need his registration and insurance. Mr. Hunter then provided his insurance card. He was once again reminded that I was requesting his registration. While speaking with Mr. Hunter I could smell a strong odor of an alcoholic beverage emitting from his breath as he spoke. I also observed his eyes to appear red and glassy. I asked how much he had to drink due to the odor, and Mr. Hunter stated one beer. When asked about how long ago, he stated an hour or two. I asked Mr. Hunter to exit the vehicle and relocate to a position to the front of my patrol vehicle. I returned to my patrol vehicle and conducted a SCDMV check. I repositioned my patrol vehicle and returned to Mr. Hunter. I explained due to the odor of an alcoholic beverage emitting from his breath as he spoke, the appearance of his eyes, and his admission to drinking a beer prior to driving I was going to offer him Standardized Field Sobriety Test (SFST), which he willing complied. The first SFST test I administered was the HGN test. I asked Mr. Hunter a few questions before beginning this test. These questions were as follows: Is there any medical conditions that he has that would stop his ability to complete these tests? Mr. Hunter stated no. Do you wear glasses? Mr. Hunter stated yes, but they were not on at this time. Do wear contacts? Mr. Hunter stated no. I began the HGN testing. I explained that he was to follow the stimulus with his eyes only and not to move his head. During the HGN Test I observed the following:
Equal pupils
No resting Nystagmus
And equal tracking with both eyes.
During the testing of smooth pursuit I observed the following:
There was nystagmus in both eyes when the stimulus was moved from center to left and center to right.
During the testing of distinct and sustained nystagmus at maximum deviation I observed the following:
There was distinct and sustained nystagmus when the stimulus was held at maximum deviation for a minimum of four seconds.
During the testing of onset of nystagmus prior to 45° I observed the following:
There was nystagmus in both eyes prior to the stimulus reaching 45°
During the testing of vertical nystagmus I observed no nystagmus when the stimulus was held at maximum deviation for a minimum of four seconds.
During the HGN part of the SFST Mr. Hunter had to be reminded numerous times to follow the stimulus with his eyes only and not move his head. Mr. Hunter also began to sway during this test.
The next test that was administered was the Walk and Turn (WAT). Mr. Hunter was asked to place his right foot in front of his left foot in a heel to toe position, his hands to his side and hold that position while the instructions was given and not to start until asked to do so. Mr. Hunter broke the starting position numerous times during the instructional phase. During the 1st nine steps Mr. Hunter missed heel to toe more than once and utilized his arms for

balance. Mr. Hunter turned improperly. During the 2nd nine steps Mr. Hunter utilized his arms again for balance, missed heel to toe on most steps. The next test that was administered was the One Leg Stand (OLS). After being explained and shown the test, Mr. Hunter was asked if he understood and if he had any questions. Mr. Hunter utilized his arms to assist in maintaining his balance during the test. His raised leg was bent during most of the test. Mr. Hunter swayed during this test Mr. Hunter also missed counted during the test. Due to Mr. Hunter statements of consuming an alcoholic beverage, the strong odor of an alcoholic beverage emitting from his breath as he spoke, and the clues from the SFST's I felt Mr. Hunter showed signs of impairment to the extent that his faculties to drive a motor vehicle were materially and appreciably impaired. Mr. Hunter was placed under arrest for DUI. I placed Mr. Hunter in handcuffs, double locked the cuffs, and advised him of his Miranda Rights, which he stated he understood. Mr. Hunter was placed in the front right seat of my patrol vehicle and seat belted in. Mr. Hunter was transported to Spartanburg County Detention Center (SCDC) for further processing. After arriving Mr. Hunter was advised that the BA room was being audio and video recorded. A copy of the Advisement of Implied Consent Rights was provided to Mr. Hunter so he could following along. Mr. Hunter stated that he understood his Implied Consent Rights. I advised Mr. Hunter that I was requesting a breathe sample. A mouth check was completed on Mr. Hunter. After the 20 minute observation period Mr. Hunter provided a breath sample and had a BAC of .29. Mr. Hunter was charged and booked into ACDC for the following charge:
56-05-2930 (A) - Driving under the Influence; .16 or higher; 1st Offense
61-06-4020 - Transport Alcohol in Motor Vehicle with Seal Broken
All copies of paperwork and the UTT's were provided to Mr. Hunter and given to SCDC staff to be placed with his personal belongings. Mr. Hunter was taken into SCDC custody.

Narrative

On the incident date, Deputy Bembenek and Master Deputy Wasserman of the Greenville County Sheriff's Office were participating Operation Rolling Thunder in Spartanburg County. We were monitoring the flow of traffic near the 65 Mile Marker on I-85 Southbound which is within Spartanburg County, SC. At that time, we observed a white Jeep Grand Cherokee with extremely dark window tint, fail to maintain its lane of travel and begin to follow another vehicle too close. At that time, we conducted a traffic stop on the vehicle.

Contact was made with the occupants of the vehicle and the driver, Catano Lanre Adeshola, informed me that he had flown up to New York with the passenger of the vehicle on Sunday. He also informed me that the passenger was his step/half brother. They stated that they had bought the vehicle in New York from a family member but were never able to provide the name of a family member that they bought it from. After further investigation, we found that the original VIN of the vehicle that was on the driver door and front windshield had been covered with new stickers with a different VIN. The VIN by the battery had also been ground off, stamped with a new VIN and had been spray painted over. There was also over spray from this change on the battery of the vehicle. The VIN that was displayed in these three places was [REDACTED]. Further investigation revealed the true VIN on the vehicles ECM. The VIN displayed on the ECM was [REDACTED]. This was the true VIN of the vehicle and was found to be stolen out of New York City, NY.

The passenger of the vehicle, Alexander Diaz, claimed to have bought the vehicle, but both occupants of the vehicle seemed to share the same knowledge and lack of knowledge of the vehicle. New York City PD confirmed that the vehicle was stolen after a hit was sent to them.

Both occupants were transported to the Spartanburg County Sheriff's Office for further processing. The vehicle was drove to the Spartanburg County Sheriff's Office as well and subsequently towed by the County Rollback. This case is cleared by arrest and our Body Worn Cameras and In Car Cameras were activated during this incident.
